KNOW ALL MEN BY THESE PRESENTS THAT the undersigned persons, acting as incorporators of this Corporation under the Colorado Nonprofit Corporation Act, sign and acknowledge the following Articles of Incorporation for such Corporation.

ARTICLE ONE: The name of this Corporation shall be Poudre Wilderness Volunteers, a Colorado Nonprofit Corporation.

ARTICLE TWO: This Corporation shall have a perpetual existence.

ARTICLE THREE: The purposes for which this Corporation is organized are to assist the Estes-Poudre and Red Feather Ranger Districts of the United States Forest Service in managing and protecting wilderness and backcountry areas within their jurisdiction. To achieve such mission, the Corporation shall recruit, train, equip and field citizen volunteers to serve as wilderness rangers and hosts for the purposes of educating the public, and shall provide other appropriate support to these wild areas as mutually agreed upon by the United States Forest Service and this Corporation. The Corporation may conduct any lawful activity pursuant to the Colorado Nonprofit Corporation Act in fulfilling such purposes.

ARTICLE FOUR. The Corporation shall have members.

ARTICLE FIVE. Upon dissolution, the assets of the Corporation shall be given as a donation, without any conditions attached, to the Roosevelt National Forest of the United States Forest Service.

ARTICLE SIX. The personal liability of a Director to the Corporation and to its Members for monetary damages for breach of a fiduciary duty as a Director shall be eliminated; subject, however, to the exceptions to such elimination of personal liability provided in Colorado Revised Statute 1973 7-22-101(1)(r).

ARTICLE SEVEN. The address of the initial registered office of the Corporation is: 3248 Silverwood Drive, Fort Collins, Colorado 80525. The name of its initial registered agent at such address is Art Bunn.
