Volunteer Trail Maintenance Training: April 25 & 28



This two-part training provides basic trail maintenance skills to volunteers and professional outfitters under permit with the Forest Service.

While geared towards volunteer crew leaders, anyone that does trail work for the Forest Service will benefit. Training consists of an evening classroom session and hands-on field practicals on a Forest Service trail. Instructors include Forest Service staff and experienced volunteer crew leaders.

Poudre Wilderness Volunteers Training: May 18-20

Volunteers spend a weekend in the woods, camping out at night and spending the day in a variety of courses. Learning and team building is made fun via an “experiential” trail practical lead by experienced volunteers using Authority of the Resource techniques.





Volunteer Spotlight

Adopt - A - Trail



The Forest Service Adopt-A-Trail (AAT) program was created to bridge the gap between trail maintenance needs and the lack of Forest Service resources to take care of those needs. The Canyon Lakes Ranger District has approximately 360 miles of official trails to maintain.

Once a trail has been adopted, volunteer crew members are taught basic trail maintenance techniques and provided with tools, hardhats, and even Forest Service staff members to help until group leaders feel confident enough to lead their own crews.

The goal is to build up leadership capacity within each organization, so crews can be self-led, and more trails can get adopted.

Basic maintenance consists of clearing the trail of downed trees, limbs and brush; and cleaning and repairing erosion control.

Of the 109 official trails on the District, 17 have been adopted by 12 different community groups. These groups represent a wide variety of entities, and include businesses, schools, clubs and churches.



One of our AAT groups is the Larimer County Horsemen's Association. They maintain their adopted trail, Lion Gulch, three times a year. Like many that adopt a trail, their members say they do it

for a variety of reasons. A chance to get outdoors in the mountains and breathe the fresh air; the feeling of accomplishment at day's end; and knowing they are making a difference in the stewardship of the trails they enjoy.

Join us on **September 29** at a new location!

The District-sponsored event will be held at historic **Mountain Park Campground**, along Colorado Highway 14 in the Cache la Poudre Canyon.

Volunteers are invited to spend half a day (9 AM - noon) to help us plant ponderosa pine seedlings in a variety of locations within the campground. This project is part of our ongoing tree restoration efforts during the current mountain pine beetle epidemic.

This family-friendly project welcomes kids ages six and up, and their parents.

Participants will receive a free hot lunch, served by Poudre Wilderness Volunteers and donated by the Arapaho Roosevelt Pawnee Foundation.

Pre-registration is required.

Historic Mountain Park Campground features structures- and trails- built by the Civilian Conservation Corps (CCC) in the 1930s.

You will be enjoying lunch near a beautiful stone shelter built by CCC workers.

The Cache la Poudre River is Colorado's only designated Wild & Scenic River, and Colorado Highway 14 is a designated state Scenic & Historic Byway.

Mountain Pine Beetles & Forest Safety

Many trees fell this winter during high wind activity. Hazard Tree Awareness (HTA) training was released in 2011, and as part of our awareness program about hazard tree safety, all employees and field-going volunteers must view the self-study presentation. Volunteers must check off the associated box about this training on page two of the volunteer agreement. Contact your Forest Service liaison to have this presentation emailed to you or your organization.

Don't forget...volunteers and Forest Service crews alike are required to carry a two-way radio or SPOT receiver if working in or traveling through designated hazard tree areas. The HTA describes use and check-out locations for these devices, as well as the location of the designated hazard tree zone.

Forest Service crews and contractors removed many dead trees along roads and parking areas last fall, and we will continue with these efforts. We continue to rely on your patrol reports to monitor the forest. To learn more about the mountain pine beetle visit: www.frontrangepinebeetle.org.
